Membership: We have now 140 effective members in 103 centres in 33 countries.

Methotrexate (MTX) trial (medium vs high dose) in the idiopathic arthritides of childhood (IAC): the goal of the trial is to assess the efficacy and safety of a 6 months course of parenteral MTX in MEDIUM (15 mg/m<sup>2</sup>/once a week max dose 20 mg/once a week) versus HIGH dose (30 mg/m<sup>2</sup>/once a week; max dose 30 mg/once a week) in children who failed a standard dose MTX  $(8-12.5 \text{ mg/m}^2/\text{once a week for 4-6 months}).$ 59 centres in 21 countries have now obtained Ethics Committee approval. A total of 203 patients have been enrolled in the screening phase with 27 patients randomised to higher dose of MTX. The trial is proceeding extremely well!!

Quality of life project in the IAC - the Childhood Health Assessment Questionnaire (CHAQ) and the Child Health Questionnaire (CHQ): goal of the project is to cross-cultural adapt and validate the CHAQ and CHQ in all languages of the PRINTO members. This will constitute the starting point for standardised functional, physical and psychosocial assessment in future clinical trials in the pediatric rheumatic diseases. The project is proceeding very well with the translations completed in **33** countries and **1479** patients collected. Next phase will be data collection for 60 healthy children and 60 children with JCA to be completed by **MARCH**, **2000**, to allow publication on Clin Exp Rheumatol by the end of year 2000.

- Cyclosporine project: The PRINTO and the PRCSG are conducting a Phase IV post-marketing surveillance study of cyclosporine-A in patients with polyarticular course IAC. A total of **170 patients (350 forms)** have been enrolled from 13 different countries. A reimbursement for the effort has been sent to all participating centres.
- **Future studies:** PRINTO is now conducting surveys to evaluate the feasibility of 2 potential new trials in IAC patients:
  - Phase II trial of a biologic agent in children with polyarticular course IAC
  - Phase III trial of a NSAID in children with IAC.

The list of countries to be contacted has been decided by the pharmaceutical companies.
